PAYMENT IN FULL ON AUCTION DAY IS REQUESTED. Forms of Payment: Cash, Certified Funds, Visa, MasterCard, Discover & American Express & checks up to \$5,000 which will be verified through our check service. If your check is not approved you will need another form of payment; we will not call your bank. Removal is auction day until 4PM, Friday and Monday February 15th & 18th from 9AM – 3PM Only. Any items not picked up will be considered abandoned. No refunds will be given. Auction Company/Seller reserves the rights to resell any purchases not paid for and retain any monies for items not picked up within the allotted checkout times.

SALES TAX:

All buyers will pay sales tax for all purchases required to be taxed, unless VALID resale/exemption certificates are given to the cashier. Your certificate exempts you from tax only on items for resale in your normal course of business.

BUYER'S TERMS AND CONDITIONS

- 1. PAYMENT** in full the day of the auction by cash, guaranteed – certified funds (cashier's check, money order), bank wire or Visa, MasterCard, American Express or Discover. Company/personal checks in excess of \$5,000 need a current irrevocable non-transferable bank letter of guarantee directed to ServCorp International, Inc. Checks under \$5,000 will be verified through our check service, if they approve we will take the check, if not you need another form of payment. Deposits, **if stated**, are 20% non-refundable (same terms as above) with balance due within 24 hours or loss of deposit. **NOTE: If auction occurs on a SATURDAY, Payment in FULL is REQUIRED (no deposits), NO EXCEPTIONS! If auction is a 2-Day auction, then Full Payment must be made EACH Auction Day.**

3. Auctioneer reserves the right to accept or reject any and all bids/increments being offered and add, group, delete, or match at the auctioneer's discretion. Any announcement by the auctioneer before the thing is bid take precedence over any printed and/or oral statements.
4. **Bidding: The bidder is responsible for knowing which items (s)he is bidding on.** Once the auctioneer says sold, the buyer has entered into a contract and is responsible for his/her item(s). The Seller shall have no responsibility whatsoever to the Buyer for the thing sold. Items will be released once full payment is made.

6. **DISPUTES:** Immediately following the striking down of the thing sold, the auctioneer has the right to reopen the bidding in a bid off and/or reopen to all. The original clerking sheet will rule after the auction.
7. **SALES TAX: Will be charged on all items sold that are required to be taxed.** All buyers will pay sales tax for all purchases required to be taxed unless proper paperwork is given to the cashier for exemption from paying state and/or local taxes. A copy of your occupational license and a copy of your sales tax registration certificate for state and/or parish. Out of state buyers will pay sales tax unless they are a registered dealer/reseller, a Resale Certificate (foreign purchaser) form must be completed (LGST 9-A/R-1079) along with providing a copy of resale certificate.
8. **NOTARY:** There will be a **\$25.00** Notary Charge, payable by the purchaser on all vehicles. No titles or bills of sale will be executed without this fee. If purchasers loses title work and a duplicate is needed the fee is **\$225 per vehicle** for lost paperwork
9. **REMOVAL:** No thing will be removed until paid for in full and receipt is in hand. Removal will be made within the announced checkout times. All other arrangements will be assessed **\$25.00** per hour (Unless otherwise stated) with deposit paid in advance. Before leaving, a ServCorp employee will cross reference items loaded to the paid receipt. **Any Jobber must present a Certificate of Insurance to ServCorp International Inc.**
