PAYMENT IN FULL IS DUE NO LATER THAN 3PM ON MONDAY MARCH 23RD. Payment can be made on auction day until 3PM, Friday 3/21 from 9AM to 3PM, & Monday 3/23 from 9AM to 3PM. Payment can be made via Cash, Certified Funds, Bank Wire, Visa, MasterCard, Discover & American Express & checks up to \$5,000 which will be verified through our check service. If your check is not approved, you will need another form of payment. Checks over \$5,000 will need a bank letter of guarantee. All card transactions incur a 3% convenience fee.

REMOVAL is on a First Come-First Serve Basis and in an orderly manner. Auction company does not handle shipping, Local pickup only. Removal is auction day until 3PM, Friday 3/21 from 9AM to 3PM & Monday 3/23 from 9AM to 3PM Only. There is no loading dock or ramp for removal/loading purposes. Buyer should supply their own removal/loading equipment, etc.; We will assist if we can, however, it is the buyers' responsibility to load their own items. Any items not removed by 3/10 deadline are considered abandoned.

This is a timed online only auction, with no onsite bidding. Each person wanting to bid must register through Proxibid with a valid credit card. You will not be approved until you have entered all the required information for the registration process.

When the bidder is awarded the bid and declared the Buyer by the Auctioneer/Timed Auction System, the bidder agrees to pay for the items. FULL PAYMENT IS DUE BY 3PM on MONDAY MARCH 23RD in US Dollars payable to ServCorp International, Inc. via cash, money order, cashier's check, or Wire Transfer (must include \$15 wire fee), & Personal/Business checks up to \$5,000. Personal or Business Check over \$5,000 will only be accepted with a Bank Letter of Guarantee. Visa, MasterCard, Discover and American Express will also be accepted. A 3% convenience fee is added for all card transactions. No bank drafts/ACH or bank counter checks are accepted. If you wish to pay by credit card, please text or email us and we will process your card on Proxibid or email you a link to pay yourself.

Buyer's Premium of 16% will be added to all purchases (ie. \$1,000 + \$160 = \$1,160 (plus notary fee and/or tax if applicable). The buyer's premium is the percentage added to the high bid amount of each item. This will be calculated and applied to your invoice, along with any other applicable fees, and will be collected by the auction company when you pay for your purchases.

Sales Tax of 9.25% will be added to the purchase of all taxable items sold. Sales Tax will be collected on final bid amount plus any buyer's premium.
